ADOPTED ON MAY 05 1992

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby not approve the draft Centre City Development Corporation ("CCDC") "Social Issues Strategy: Defining the Redevelopment Agency's Role in Reducing Homelessness in Centre City San Diego 1992-2002" ("Strategy") and that no further distribution of the strategy be done.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to work with CCDC to develop a social service strategy with all other providers' expertise for input, and to return to this Council with a revised social service strategy before distribution.

BE IT FURTHER RESOLVED, that this Council hereby supports the City Manager in his request for an overall strategy for serving the homeless needs of The City of San Diego with development of a City task force.


BE IT FURTHER RESOLVED, that the City Manager be and is hereby directed to return in sixty (60) days with a strategy for creating adequate emergency homeless shelters based upon the



needs outlined in City Manager Report No. 92-54, including work and community service outreach and input from homeless organizations and providers in that area, and the homeless people themselves.
