BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. SAFETY WEST, 2. VALLEN SAFETY SUPPLY CO., 3. R. J. SUPPLY CO. and 4. SAFETY SUPPLY AMERICA are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of SAFETY PROTECTION EQUIPMENT as may be required for a period of one (1) year beginning May 1, 1992 through April 30, 1993, per prices on file in the Purchasing Department, with options to renew the contract for three (3) additional one (1) year periods as follows:


1. SAFETY WEST for Items 1, 2 and 3, for a total estimated cost of \$1090.00; terms 1% 20 days, plus sales tax, with option period increases not to exceed 10% of prices in effect at the end of each prior contract period.
2. VALLEN SAFETY SUPPLY CO. for Items 5, 8 and 11, for a total estimated cost of \$3402.00; terms net 30 days, plus sales tax, with option period increases not to exceed 20% of prices in effect at the end of each prior contract period.
3. R. J. SUPPLY CO. for Items 12 and 14, for a total estimated cost of \$8,926.00; terms 1% 20 days, plus sales tax, with option period increases not to exceed 10% of prices in effect at the end of each prior contract period.
