BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by Jeffrey R. Lundstrom, Registered Civil Engineer, entitled "PARCEL MAP W.O. NO. 900100 being a division of Parcel 1 of Parcel Map No. 16195, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County, August 21, 1990, as file No. 90-457212 of Official Records," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said parcel map and the division of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Carmel Mountain Road, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Council hereby accepts on behalf of The City of San Diego, the easement with the right of ingress and egress for the construction and maintenance of water facilities, as granted and shown on the map and subject to the conditions set forth thereon.


