RESOLUTION NUMBER R- 279922

ADOPTED ON MAY 11 1992

WHEREAS, the travel industry is America's largest employer, directly supporting 5.9 million jobs that generated nearly \$84 billion in wages and salaries in 1990 and produced more than \$43 billion in federal, state and local revenues; and

WHEREAS, international tourism has been the number one export in the United States for the last three years, playing a critical role in our country's overall balance of trade; and

WHEREAS, in 1990, nearly 39 million international visitors came to the United States, contributing nearly \$41 billion to our economy, directly supporting 840,000 jobs and providing a favorable trade balance of \$5.3 billion; and

WHEREAS, tourism is vital to the economic prosperity of the San Diego region, contributing more than \$3.5 billion in total economic impact; and

WHEREAS, tourism provides some 125,000 jobs for San Diego area residents, as well as promoting the intercultural and geographic understanding of our residents; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council recognizes the significance of the tourism industry to the enhancement of trade, understanding and international goodwill in the San Diego area.

BE IT FURTHER RESOLVED, that May 17 through 23, 1992 be and the same is hereby designated "TOURISM WEEK" in The City of San Diego.
