RESOLUTION NUMBER R- 279924

ADOPTED ON MAY 11 1992

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager is hereby authorized to file documents with the California Department of Commerce to expand the San Ysidro/Otay Mesa Enterprise Zone in accordance with regulations promulgated by the Department of Commerce pursuant to state law (AB 251 of 1989).

2. That the City Manager is hereby authorized to take actions necessary to expand the San Ysidro/Otay Mesa Enterprise Zone to include the area as described in Attached A hereto, which is by this reference incorporated herein.

3. That the Council of The City of San Diego hereby finds that the San Ysidro/Otay Mesa Enterprise Zone, as expanded, has been found to be an area with high unemployment and limited employment opportunities for area residents, and that designation as an enterprise zone is necessary to the creation of jobs by private enterprise.

4. That the City Manager is hereby authorized to expedite the necessary development plan and permit processing and building permit issuance for commercial and industrial projects within the San Ysidro/Otay Mesa Enterprise Zone, as expanded, when such expansion is approved by the California Department of Commerce.



Starting at the intersection of State Highway 905 and Beyer Boulevard and then southwesterly along State Highway 905 to Howard Avenue; north along Howard Avenue to Iris Avenue; east along Iris Avenue to the San Diego and Arizona Eastern Railroad; northwesterly along said Railroad to a point intersecting with the northern lot line of lot 7, South San Diego Industrial park, Unit 2, Map 9557; east along said northern lot line to a line marking the westernmost area zoned for commercial and industrial uses; north on said line to the intersection of Sewell Avenue and Madden Avenue; north on Madden Avenue to Coronado Avenue; east on Coronado Avenue to Beyer Boulevard; and southeasterly on Beyer Boulevard to State Highway 905.
