WHEREAS, the City Treasurer has received such a Notice of Lost Bond and Lost Instrument Bond in connection with the First San Diego River Improvement Project Assessment District 4007, Bond Series 3657, in the amount of \$10,000.00, which has been lost, destroyed or wrongfully taken; and

WHEREAS, in order for the lost bond to be replaced, the City Council must authorize such replacement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the replacement of the City of San Diego 1915 Act Limited Obligation Bond, certificate number M113, First San Diego River Improvement Project Assessment District No. 4007, Bond Series 3657, in the amount of \$10,000.00, be and is hereby authorized.
