BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$314,679 from Sewer Revenue Fund 41506, CIP 43-004, Annual Allocation - Freeway Relocation, is hereby authorized, solely and exclusively to provide funds for Utility Agreement No. 25654; and the expenditure of an amount not to exceed \$49,064 from Water Revenue Fund 41502, CIP 73-024, Annual Allocation - Freeway Relocation, is hereby authorized, solely and exclusively to provide funds for Utility Agreement No. 29089.
