RESOLUTION NUMBER R- 279929

ADOPTED ON MAY 11 1992

WHEREAS, the Amalgamated Association of Street Electric Railway and Motorcoach of America was formed in 1892 with the motto of "Freedom through Organization;" and

WHEREAS, with the demise of the electric car transit system, the organization changed its name to the Amalgamated Transit Union; and

WHEREAS, the San Diego Bus Drivers Union, Local 1309 of the Amalgamated Transit Union was organized May 6, 1942 to represent the clerical support maintenance workers and bus drivers of San Diego County's transit operators; and

WHEREAS, the San Diego Bus Drivers Union presently represents more than 1,000 active and retired employees of San Diego Transit, National City Transit, and Southwest Coaches Incorporated; and

WHEREAS, on Sunday, May 17, Union members and their families will gather at De Anza Cove on Mission Bay for a picnic and other festivities in celebration of the 50th anniversary of the San Diego Bus Drivers Union; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that this Council, for and on behalf of the people of San Diego,
hereby declares Sunday, May 17, 1992 as "SAN DIEGO BUS DRIVERS
UNION DAY" in San Diego.
