WHEREAS, additional San Diego sales will occur in Convair's commercial aircraft work (3,500 employees) and the company's Electronics Division (2,600 employees); and

Mayor O'Connor has called for the creation of a committee
consisting of the Mayor, Councilmember George Stevens, the City
Manager and representatives from Chamber of Commerce, Economic

leaders, to review the potential sale of General Dynamics and
