RESOLUTION NUMBER R- 279942

ADOPTED ON MAY 12 1992

WHEREAS, section 9 of the Annual Salary Ordinance No. O- 17781 (NEW SERIES), for fiscal year 1993, provides that those classified personnel who shall be eligible for and entitled to receive overtime compensation shall be approved by Council resolution after determination by the Civil Service Commission and City Manager and/or nonmanagerial department head; and

WHEREAS, the classifications now recommended to the Council have been appropriately determined to be so eligible and are submitted for Council approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to the authority of section 9 of the annual salary ordinance, the classifications of personnel in the classified service of The City of San Diego eligible for premium or regular rate overtime, as set forth in Exhibit "A" hereto, are hereby approved for such status in accordance with the terms and conditions recited therein, effective upon adoption of this resolution through June 30, 1993.
