RESOLUTION NUMBER R- 279954

ADOPTED ON MAY 12 1992

WHEREAS, the Community Dispute Resolution Trust, a nongovernment organization, which supports and encourages the establishment of a national network of autonomous local community dispute resolution centers throughout South Africa, has designated a 23-member delegation to tour the United States; and

WHEREAS, the members of this delegation are either active mediators in their own communities or are engaged in other justice and peacemaking activities; and

WHEREAS, members of this delegation are visiting selected sites in the United States to study programs providing community mediation, to meet with mediators, program administrators, judges, attorneys, other court officials, and conflict resolvers; and

WHEREAS, the United States Information Agency, the African American Institute of Washington, D.C., and Conflict Management Initiatives of Evanston, IL., are sponsoring this tour; and

WHEREAS, the dispute resolution community of San Diego, a diverse and collaborative network of local organizations and individuals is hosting these South African peace emissaries; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby supports such international and cross-cultural exchanges, and honors such movements toward peaceful

resource development, and toward empowerment and justice for communities and neighborhoods of South Africa and San Diego.
