BE IT RESOLVED, by the Council of The City of San Diego hereby authorizes the City Manager to execute a contract with the California Commercial Asphalt Corporation for the RESURFACING OF VARIOUS CITY STREETS GROUP "B" FY92.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$4,610,341.30 from Gas Tax Fund 302191, \$70,000.00 from Water Utility Operations Fund No. 41500; and \$105,000.00 from Sewer Revenue Fund No. 41506 for a total expenditure not to exceed \$4,785,341.30, is hereby authorized solely and exclusively for providing funds for said project and related costs.
