ADOPTED ON MAY 26 1992

BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT CAMINO DEL RIO SOUTH AND MISSION CITY PARKWAY, FOURTH AVENUE AND GRAPE STREET, AND AT RICHMOND STREET AND ROBINSON AVENUE, San Diego, California, on file in the Office of the City Clerk of San Diego, California on MAY 26 1992, and bearing official document No. W.O. 119804, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT CAMINO DEL RIO SOUTH AND MISSION CITY PARKWAY, FOURTH AVENUE AND GRAPE STREET, AND AT RICHMOND STREET AND ROBINSON AVENUE.

BE IT FURTHER RESOLVED, that the expenditure of \$280,000.00 from CIP 68-010.0, ANNUAL ALLOCATION - CONSTRUCTION TOP 10-15 PRIORITIZED TRAFFIC SIGNALS, FUND 30300, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to retain excess budgeted funds, if any, in CIP 68-010.0.
