
RESOLUTION NUMBER R- 279969

ADOPTED ON MAY 26 1992

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of grant deeds of MIRA SORRENTO ASSOCIATES, a California general partnership, dated August 7, 1991, LUSK/MIRA MESA, a California limited partnership, dated April 23, 1991, and DONN H. GOSS and BEVERLY J. GOSS, dated May 15, 1991, all executed in favor of The City of San Diego, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR- 279969-1, RR- 279969-2 and RR- 279969-3, granting to said City easements for public street purposes in a portion of Parcel 6 of Parcel Map No. 15907, and in a portion of Acre Lot 34 of Sorrento Lands and Townsite, Map No. 483, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named MIRA MESA BOULEVARD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
