WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the easterly five (5) feet of Kettner Boulevard south of Market Street, as more particularly shown on Drawing No. 17795-B, on file in the office of the City Clerk as Document No. RR- $\frac{279971}{}$ , which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.
- 2. That this resolution shall not become effective unless and until the following condition has been met: Permits must be issued for the removal and replacement of the existing easterly curb, gutter, and sidewalk five (5) feet to the west.

In the event the above condition is not completed within three (3) years following the adoption of this resolution, then this resolution shall become void and be of no further force or effect.

3. That the City Engineer shall advise the City Clerk of the completion of the aforementioned condition, and the City Clerk shall then cause a certified copy of the resolution, with

drawing, attested by him under seal, to be recorded in the office of the County Recorder.


