RESOLUTION NUMBER R- 279988

ADOPTED ON MAY 26 1992

WHEREAS, the FY 1991 Special Projects Program was designed by the San Diego Commission for Arts and Culture ("Commission") to provide funding for programs which foster the stabilization and diversification of San Diego's cultural base, enhance the quality of life in the City's neighborhoods, and pursue the vision of San Diego as a cultural destination; and

WHEREAS, the FY 1991 Special Projects Program was approved by the City Council on July 24, 1990, by Ordinance No. 0-17504 (N.S.), with an allocation of \$566,914.00 in Transient Occupancy Tax ("TOT") Special Promotional Program funding; and

WHEREAS, on January 28, 1991, Resolution No. R-277260 was adopted to approve the funding recommendations of the Commission for the Special Projects Program and to authorize the City Manager to execute contracts with the organizations recommended for Special Projects Program funding; and

WHEREAS, the Children's Museum of San Diego ("Children's Museum") was one of the organizations approved for Special Projects Program funding in the amount of \$23,667 for the purpose of sponsoring a three (3) month exhibition during FY 1992 entitled "Remember the Children," an exhibition about the Holocaust for children and families; and

WHEREAS, the City Manager subsequently entered into a contract with the Children's Museum for the above-described purpose, which contract was filed on May 9, 1991, with the City Clerk as Document No. C-03598; and

WHEREAS, due to unforeseen scheduling problems with the U.S. Holocaust Memorial Council, which is co-sponsoring the exhibition entitled "Remember the Children," the Children's Museum has requested that the City amend its existing contract with the Children's Museum to extend the dates of performance; and

WHEREAS, the City Council finds that the "Remember the Children" exhibition will be an important event for San Diego's children, and will teach them not only the history of the Holocaust and genocide, but also the value of respecting cultural differences; and

WHEREAS, the City Manager recommends that the contract with the Children's Museum be amended to extend the date of termination of the agreement to June 30, 1993, from the original termination date of October 31, 1991, and further recommends that the amount of \$23,667 originally encumbered and approved for funding this contract be encumbered through the next fiscal year (FY 1993); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute an amendment to the existing contract with the Children's Museum (City Clerk Document No. C-03598) to extend the date of termination from October 31, 1991, to June 30, 1993.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to encumber and expend the amount of \$23,667 originally encumbered in the FY 1991 Special Projects Program funds for the above-described purpose.
