
RESOLUTION NUMBER R- 279990

BE IT RESOLVED, by the Council of The City of San Diego, that Change Order No. 2, dated March 5, 1992, heretofore filed with the City Clerk of said City as Document No. RR-279990, issued in connection with the contract between The City of San Diego and Dietrich Corporation regarding Water and Sewer Main Replacement Group 466, said contract having been filed in the office of the City Clerk as Document No. RR-277130, be and is hereby approved, together with the changes therein set forth, amounting to a net decrease in the contract price of \$78,973.51 (consisting of \$51,692.51 for Sewer Fund 41506 and \$27,281.00 for Water Fund 41500, Group Job 466 Sewer Main Replacement, CIP 44-001.0, and Group Job 466, Water Main Replacement, CIP 73-083.0, respectively).
