



RESOLUTION NUMBER R- 280010
ADOPTED ON MAY 26 1992

BE IT RESOLVED, by the Council of The City of San Diego, that the proposal by Jehovah's Witnesses of San Diego to construct a meeting room on the Plaza level of the San Diego Jack Murphy Stadium ("Stadium") in the City of San Diego, California, is hereby accepted.
