BE IT FURTHER RESOLVED, that the City Auditor & Comptroller is hereby authorized to transfer an amount not to exceed \$1,233,852 within the Sewer Revenue Fund No. 41506, consisting of \$909,291 from CIP 46-158.0, Mission Bay Sewage Interceptor System and \$324,561 from CIP 46-124.0, Alvarado Filtration Plant - Joint Laboratory, to CIP 4-104.0, North Metro Interceptor Sewer.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,298,852 from Sewer Revenue Fund No. 41506, CIP 46-104.0, North Metro Interceptor, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
