RESOLUTION NUMBER R-280022

ADOPTED ON MAY 26, 1992

WHEREAS, the Council of The City of San Diego pursuant to Resolution No. R-274663 on October 31, 1989 adopted Alternative IV to the Clean Water Program as the preferred alternative for the Clean Water Program to comply with the requirements of the Clean Water Act; and

WHEREAS, the Council authorized a Partial Consent Decree that provided a time table for construction of the projects listed in Alternative IV; and

WHEREAS, the Partial Consent Decree contains express language for modification of the projects listed in Alternative IV upon approval of the U.S. Environmental Protection Agency, the State of California and the U.S. District Court; and

WHEREAS, the Council on April 27, 1992 and May 4, 1992 reviewed and evaluated the projects required to be constructed under Alternative IV in consideration of the lack of harm to the environment, the need for additional capacity, the need for reclaimed water, and the total cost of Alternative IV; and

WHEREAS, the Council desires to revise the projects to be built under the Clean Water Program and the Partial Consent Decree to include a list of projects known collectively as the Consumers' Alternative to the Clean Water Program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to the Consumers' Alternative, the following revisions are made to Clean Water Program projects:

- 1. The South Bay secondary and reclamation plants and their associated conveyance systems are hereby recommended for deletion.
- 2. The Mission Gorge and associated conveyance systems are hereby recommended for deletion.
- 3. The SS-1, SS-2 and SS-3 conveyance pipelines for the South Bay projects are hereby recommended for deletion.
- 4. The Point Loma treatment plant shall remain at advanced primary pending further orders of the court and/or remedial legislation defining its standards of treatment, except that the following projects shall continue:
 - a. Digesters 7, 8 and 9
 - b. Two (2) grit tanks
 - c. Sedimentation basins 11 and 12
 - d. New administration/laboratory building
 - e. South effluent line
 - f. New sludge pump station
 - g. Ocean outfall extension
 - h. Ocean outfall parallel replacement
- 5. The following secondary and reclamation plants are proposed to be constructed on a revised schedule:

Phase I (1992-2003)

- a. North City
- b. Miramar FIRP and NTCP digesters
- c. Southern sludge disposal facility

Phase II (2003-2050)

- a. Mission Valley
- b. Otay

6. The balance of Clean Water Program projects, including the North City and Miramar site conveyance systems, shall continue per the Consumers' Alternative; present design work on the San Diego River outfall shall halt pending environmental review of alternative outfall locations; and staff shall return to Council with a final recommended location of the outfall or recommended means of disposal.

- 7. All municipal sewer upgrades shall continue as detailed in Attachment III to the City Manager's recommendation of May 1, 1992, on file in the office of the City Clerk as Document No. RR-280022.
- 8. Staff shall contact the U.S. Department of Justice and the U.S. District Court at the earliest possible time to discuss a modification of the Consent Decree pending in <u>U.S.A. v. City of San Diego</u> in accordance with the above direction.
- 9. Staff shall develop a financing plan to implement the above, including retention of required consultants subsequent to judicial approval of the foregoing.
