RESOLUTION NUMBER R-_____

ADOPTED ON MAY 26 1992

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO SUPPORT THE SUBMISSION OF A PROPOSAL TO THE DEPARTMENT OF DEFENSE FOR THE LOCATION OF A DEFENSE FINANCE AND ACCOUNTING FACILITY WITHIN THE CITY LIMITS OF THE CITY OF SAN DIEGO.

WHEREAS, the Department of Defense ("Department") has announced plans to consolidate its Defense Finance and Accounting Service Facilities ("Facility") at a select number of locations throughout the United States; and

WHEREAS, the Department has requested proposals from communities wishing to be considered as a site for a Facility; and

WHEREAS, the Facility is estimated to employ approximately 4,000 or 7,000 employees with an average salary and benefits of \$35,000 per employee annually; and

WHEREAS, the Council of The City of San Diego on Monday, May 11, 1992, directed the City Manager to bring forward a recommendation for consideration of submittal of a proposal to the Department of Defense for the location of a Defense Finance and Accounting Service Facility; and

WHEREAS, the City Manager has reviewed the various options for the location of a Facility; and

WHEREAS, it is in the public interest that the selection of the site for location of the Facility would provide substantial economic benefit to the City of San Diego and the region through direct and indirect creation of job opportunity, enhance the


local tax base, and provide additional support to military personnel located in the region; and

WHEREAS, it is in the public interest that the Council of The City of San Diego, working with other public and private agencies, approve the submission of a proposal to the Department of Defense not later than Monday, June 1, 1992; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council hereby authorizes the City Manager to submit a proposal expressing interest and indicating an intent by The City of San Diego to provide the necessary land at a cost not to exceed one dollar per year (with the cost of all improvements and building construction to be paid by the Department of Defense) for a Facility for approximately 4,000 employees.

BE IT FURTHER RESOLVED, that The City of San Diego will assist in securing the necessary financing for the Facility by the sale of bonds or other appropriate financial instrument to develop the necessary Facility and related improvements. The City Manager, working with other public and private agencies, is also authorized to develop incentives to assist in meeting the preferred items in the Department of Defense proposal.
