BE IT RESOLVED, by the Council of The City of San Diego that the low bid of RIDGE AUTO-MARINE SUPPLY is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing AUTOMOTIVE FILTERS AND FILTER ELEMENTS as may be required for a period of one (1) year beginning June 1, 1992 through May 31, 1993 per prices on file in the Purchasing Department; terms 1% 30 days, plus sales tax, with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 6%.

BE IT FURTHER RESOLVED, that in the event the Contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to the specifications.
