BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bids of 1. JOHNSTON PUMP/GENERAL VALVE, INC., 2. SLOAN ELECTRIC CO. and 3. MARDEN SUSCO INC., meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute a contract for FOUR (4) EACH VERTICAL TURBINE PUMPS, FOUR (4) EACH PUMP CONTROL VALVES, REQUIRED SWITCHGEAR CONTROLS AND MISCELLANEOUS PIPE FITTINGS as follows:

1. JOHNSTON PUMP/GENERAL VALVE, INC. for Schedules I, II, III and IV - Pump/Motor with spare parts for a total cost of \$107,300.00; terms net plus sales tax.
2. SLOAN ELECTRIC CO. for Schedules I and II for Electric Controls for a total cost of \$19,527.00; terms net 30 days plus sales tax.
3. MARDEN SUSCO INC. for Schedule I, Control Valves and Miscellaneous Fittings, and Schedules II and III - Control Valves and Miscellaneous Fittings, for a total cost of \$32,373.00; terms 2% 20 days plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$170,840.35, from Department No. 700, Fund No. 40012, Organization No. 385, Object Account No. 3306, and Job Order Nos.

182148, 182128, 182138 and 182118, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
