
2. That signage shall indicate both the old street name and the new street name for a period of one (1) year following the adoption date of this resolution, for the convenience of the general public.

3. That the installation and removal of the necessary signs and markings be, and the same are hereby authorized.

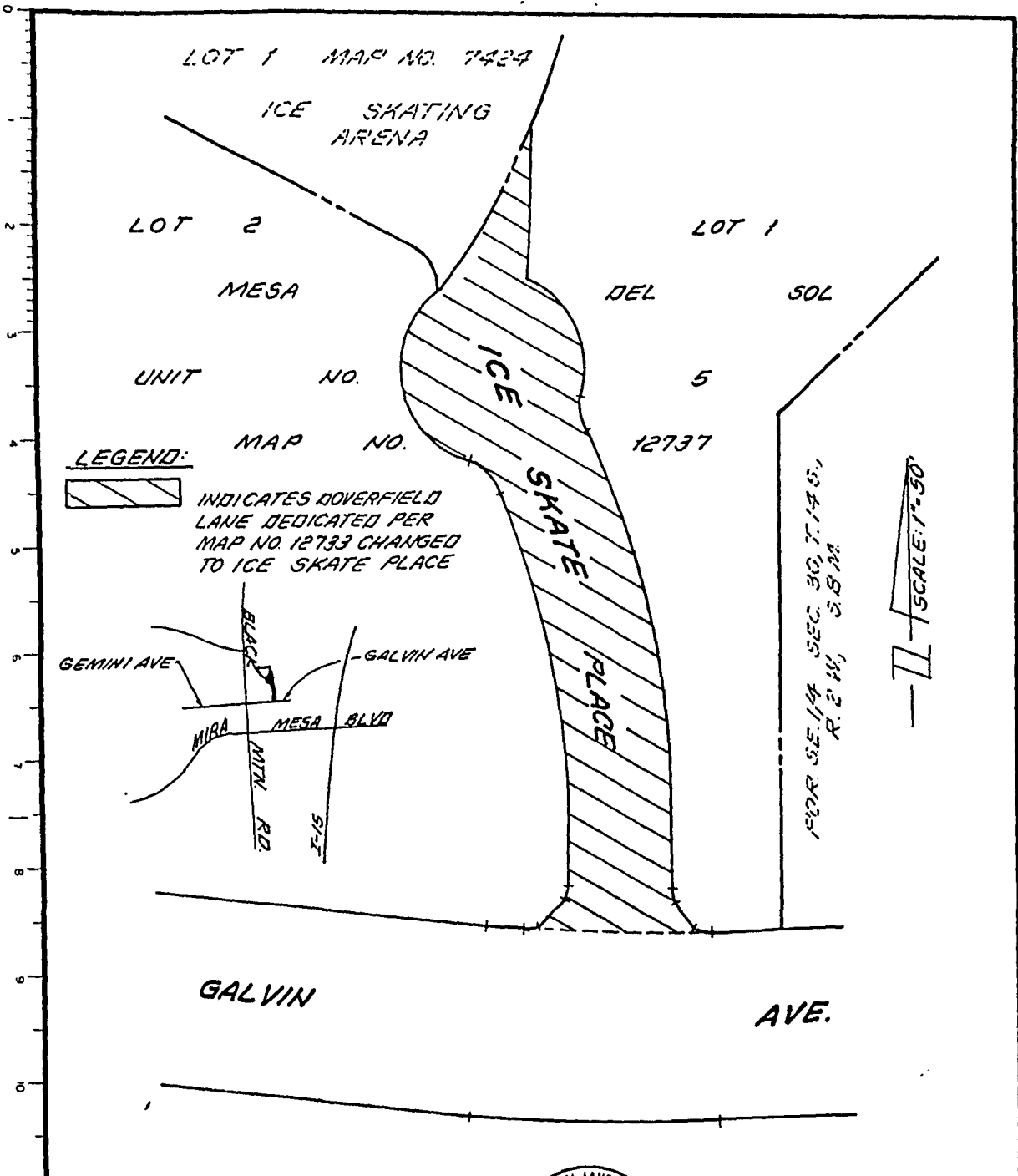
4. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.



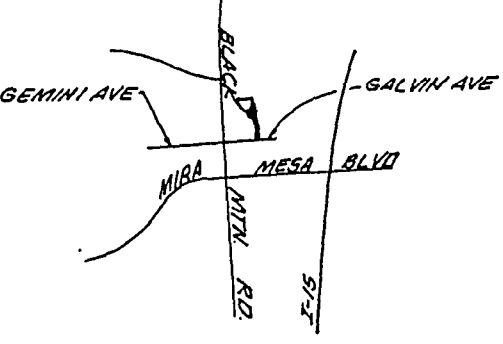
