BE IT RESOLVED, by the Council of The City of San Diego that the sole bid of FLIR SYSTEMS, INC., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of a FORWARD LOOKING INFRARED IMAGING SYSTEM (FLIR Systems, Inc. #2000 F/V) at a cost of \$154,800.00 and on-site training at a cost of \$2,360.00, for a total combined cost of \$157,160.00, terms net 30 days, plus applicable sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$169,157.00 from Fund No. 10132, Department No. 10132, Organization No. 200, Object Account No. 6010, and Job Order No. 001992, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
