BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bids of 1. NAPA AUTO PARTS, 2. CHAMPION AUTO PARTS, and 3. WETMORE'S are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of MISCELLANEOUS HYDRAULIC BRAKE COMPONENTS, FRICTION MATERIAL AND HEAVY DUTY AIR BRAKE COMPONENTS as may be required for a period of one (1) year beginning June 1, 1992 through May 31, 1993, per prices on file in the General Services Department, Equipment Division, with options to renew the contract for four (4) additional one (1) year periods, under the same terms and conditions, as follows:

1. NAPA AUTO PARTS for Section I - Hydraulic Brake Components; terms 2% 20 days, plus sales tax. Estimated City expenditure under Section I is \$5,000.00 annually.
2. CHAMPION AUTO PARTS for Section II - Friction Material; terms Net 30 days, plus sales tax. Estimated City expenditure under Section II is \$5,000.00 annually.
3. WETMORE'S for Section III - Heavy Duty Air Brake Components; terms 1% 30 days, plus sales tax. Estimated City expenditure under Section III is \$50,000.00 annually.


