

RESOLUTION NUMBER R-280092

ADOPTED ON JUN 08 1992

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on April 2, 1992, to consider the proposed amendment to the Southeast San Diego Community Plan redesignating land uses for the proposed San Diego Police Department Central Division Substation site, at the northeast corner of 30th Street and Imperial Avenue, from Multiple Use (Residential/Commercial) and Industrial to Institutional in order to facilitate the decentralization efforts of the Police Department; and

WHEREAS, the Planning Commission approved and recommended adoption by the City Council of said amendment; and

WHEREAS, the City Council has considered all maps, exhibits and written documents contained in the file for this project on record in The City of San Diego, and has considered the oral presentations given at the public hearing; and

WHEREAS, following the public hearing, the City Council, by a majority vote, approved the amendment to the Southeast San Diego Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the Southeast San Diego Community Plan amendment, a copy of which is on file in the office of the City Clerk as Document No. RR-280092.

BE IT FURTHER RESOLVED, that the Council has examined the existing CSR-2-R-1500 and I-1 zones and the proposed change to


