BE IT RESOLVED, by the Council of The City of San Diego, that the low acceptable bids of 1. INDUSTRIES SUPPLY CO., 2. STANDARD PLUMBING & INDUSTRIAL SUPPLY CO. and 3. KEENAN SUPPLY are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of PLUMBING FIXTURES FOR CITY FACILITIES as may be required for a period of one (1) year beginning May 1, 1992 through April 30, 1993, per prices on file in the Purchasing Department as follows:

1. INDUSTRIES SUPPLY CO. for a total estimated cost of \$10,541.13; terms 2% 20 days, plus sales tax, with options to renew for an additional one (1) year period at prices not to exceed 12% of prices in effect at the end of the prior contract period.
2. STANDARD PLUMBING & INDUSTRIAL SUPPLY CO. for a total estimated cost of \$47,994.53; terms 2% 30 days, plus sales tax, with options to renew for an additional one (1) year period at prices not to exceed 5% of prices in effect at the end of the prior contract period.
3. KEENAN SUPPLY for a total estimated cost of \$19,769.00; terms 2% 20 days plus sales tax, with an option to

renew the contract for an additional one (1) year period  
with prices not to exceed 5% of prices in effect at the end  
of the prior contract period.
