

RESOLUTION NUMBER R-280135

ADOPTED ON JUNE 15, 1992

WHEREAS, the safe disposal of low-level radioactive waste is a major concern to both industry and government; and

WHEREAS, under federal-mandate, a regional disposal site has to be acquired and a disposal facility constructed and in operation by January 1, 1993; and

WHEREAS, should California fail to open a disposal facility by January 1, 1993, the State will be in default of Article IV of the Southwestern Compact Consent Act (Public Law 100-712) which requires California to "cause a regional disposal facility to be developed in a timely manner"; and

WHEREAS, states that fail to provide a disposal facility by January 1, 1996, for all such wastes must assume ownership and take possession or assume direct and indirect liability for the waste; and

WHEREAS, it is in the best interests of San Diego to encourage the State to provide for safe and efficient disposal of low-level radioactive waste; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the State of California is hereby encouraged to expeditiously provide for the efficient and environmentally safe disposal of low-level radioactive waste (LLRW).

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to continue to monitor and work with local industries


