A RESOLUTION OF THE CITY OF SAN DIEGO
ACCEPTING PHASE II OF THE URBAN FORM ACTION
PROGRAM.

WHEREAS, on June 10, 1991, the Transportation & Land Use Committee directed staff to organize a public workshop to seek revalidation of the City's vision of its desired urban form and formulate comprehensive strategies to implement public policy goals; and

WHEREAS, on November 1 and 2, 1991, the Urban Form Workshop was held with San Diego citizens where key issues and alternative solutions were discussed on such topic areas as sensitive resources, neighborhood character, transportation systems, public facilities, regional planning, economic development and social resources; and

WHEREAS, the Urban Form Workshop participants divided into six issue groups (regional planning, economic development, settlement patterns, sensitive resources, social resources, and public facilities) to discuss problems and issues associated with their assigned issue and recommend possible solutions and recommendations; and

WHEREAS, the workshop concluded with citizens consensus on a vision and a direction the City of San Diego should take in regard to Urban Form by formulating THE URBAN FORM ACTION PLAN; and


WHEREAS, on November 4, 1991, the Council of The City of San Diego, held a public hearing and accepted the proposed Action Plan and directed City staff to prepare an implementation program to be presented to the City Council in January, 1992; and

WHEREAS, during the week of January 6, 1992, the six Urban Form Issue Groups met again to reevaluate their recommendations and to discuss how they should be implemented; and

WHEREAS, City staff compiled the Issue Groups recommendations for implementation into THE URBAN FORM PHASE II ACTION PROGRAM; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby accepts THE URBAN FORM PHASE II ACTION PROGRAM and directs staff to prepare a fiscal analysis of the report and a phasing program indicating when each recommendation could be implemented.
