WHEREAS, the Centre City Development Corporation, Inc., has reviewed and discussed said proposed Predevelopment Loan Agreement and has recommended that the Agency enter into the Predevelopment Loan Agreement; and

WHEREAS, the City Council has duly considered all the terms and condition of the proposed Predevelopment Loan Agreement and believes it is in the best interests of the City and the health,

WHEREAS, as part of carrying out the Project, the Agency has established the Marina Low and Moderate Income Housing Fund, and has and will deposit funds therein as provided by the California Community Redevelopment Law (Health and Safety Code section 33000, et seq.); and

WHEREAS, the Agency desires to use funds from the Marina Low and Moderate Income Housing Fund to pay part of the costs for the housing under the proposed Predevelopment Loan Agreement for very low and low income persons; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby authorizes the use of funds, as a loan, from the Marina Low and Moderate Income Housing Fund, in the amount of twenty-eight thousand dollars (\$28,000) to pay for development consultant fees.
