BE IT FURTHER RESOLVED, that Council Policy 300-7 regarding consultant services selection is hereby waived due to the rapid rate of erosion of the Bermuda Avenue retaining wall/seawall.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$35,000 (thirty-five thousand dollars) from CIP 52-544.0, Bermuda Avenue Seawall, Proposition "A" Interest Fund 30300, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
