BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Jerry A. Helms, Registered Civil Engineer, entitled "PARCEL MAP W.O. 900511, being a division of all of Lot 94 and all those portions of Lots 61, 62, 79, 95, 96, 141, and 161 and a portion of Henrietta Drive vacated to public use all in Encima de San Diego in the City of San Diego, County of San Diego, State of California, according to Map No. 1546 filed in the Office of the County Recorder of San Diego County, March 18, 1913," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the division of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Skyline Drive, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Skyline Drive, adjacent and contiguous to Parcels 1 through 4 inclusive, all as shown on the parcel map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of sewer facilities, as granted and shown on the parcel map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon the parcel map, as and for the act of the Council, that said Council has approved the parcel map and that the portion of a street is accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer facilities, all as granted and shown on the parcel map are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit the map to the Clerk of the Board of Supervisors of the County of San Diego, California.
