RESOLUTION NUMBER R- 280174

ADOPTED ON JUN 22 1992

WHEREAS, in 1990 Government Code section 87306.5 was added to the Political Reform Act; and

WHEREAS, Government Code section 87306.5 requires that no later than July 1 of each even-numbered year, the City Council as the code reviewing body of local agencies' Conflict of Interest Codes, shall direct every local agency which has adopted a Conflict of Interest Code ("Code") to review its Code; and

WHEREAS, local agencies include not only City departments, but also City-owned Corporations, certain City board's and commissions, and certain other local agencies for whom the City Council serves as code reviewing body; and

WHEREAS, Government Code section 87306.5 requires that if a change in a local agency's Code is necessitated by changed circumstances, an amended Code shall be submitted to the code reviewing body; and

WHEREAS, upon review of a local agency's code, if no change in the code is required, the local agency head shall submit a written statement to that effect to the code reviewing body no later than October 1 of the same year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby directs all local agencies which have adopted Conflict of Interest Codes, to review all existing Codes
