RESOLUTION NUMBER R- 280187

ADOPTED ON JUN 22 1992

WHEREAS, on December 11, 1990, the San Diego City Council by Resolution No. RR-277077, adopted the "City of San Diego's Urban Water Management Plan and Conservation Plan" ("Plan"); and

WHEREAS, the Plan has eight (8) integrated and complimentary water conservation programs, including a City Facilities Retrofit Program ("Retrofit Program") for the installation of ultra-low flush toilets in City-owned buildings and facilities; and

WHEREAS, the Board of the County Water Authority ("CWA") authorized the implementation of the Public Institutions Conservation Assistance Program; and

WHEREAS, the Metropolitan Water District of Southern California ("MWD") approved matching funds for this program; and


WHEREAS, funds from the CWA and the MWD will pay for more than eight hundred (800) toilets that will be replaced with ultra-low flush toilets in City-owned facilities and buildings during the first year of this conservation program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized to enter into a Memorandum of Understanding with the CWA, for the purpose of participating in the CWA's Public Institutions Conservation Assistance Program.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to enter into an agreement with the MWD for receipt of funds from MWD to be used to implement the City Facilities Retrofit Program.
