RESOLUTION NUMBER R- 280188
ADOPTED ON JUN 22 1992

WHEREAS, in 1984, the City Council approved a lease (the "Lease") between the County and City of San Diego, as joint lessors, and Video Services, Inc., as lessee ("Lessee"); and

WHEREAS, the Lease is due to expire by its terms on December 31, 1994, and neither the Lessee nor the City wish to extend the term of the Lease beyond such date; and


WHEREAS, Section 1.03 of the Lease requires that the Council of The City of San Diego adopt a resolution approving transmittal by the City of written notification to Lessee, thirty (30) months prior to the date on which Lessee is to vacate the premises, that it will be required to vacate the premises; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized to prepare, execute and transmit, for and on behalf of The City of San Diego, a thirty (30) month Notice to Vacate to Lessee as required by Section 1.03 of the Lease.

BE IT FURTHER RESOLVED, that said thirty-month Notice to Vacate shall be delivered to Lessee no later than June 30, 1992,

and that it shall give notice to Lessee that it must vacate the premises no later than December 31, 1994.
