BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a renewal of the Memorandum of Understanding between the COUNTY OF SAN DIEGO, METROPOLITAN TRANSIT DEVELOPMENT BOARD, SAN DIEGO ASSOCIATION OF GOVERNMENTS, SAN DIEGO UNIFIED PORT DISTRICT, SAN DIEGO UNIFIED SCHOOL DISTRICT AND CALTRANS, for the continued coordination of the certification process required under the City's Minority and Women Business Enterprise Program, under the terms and conditions set forth in the Memorandum of Understanding on file in the office of the City Clerk as Document No. RR-280189. This agreement may be cancelled with thirty-day notice if a mutual agreement cannot be reached as to what is the proper definition of a minority or woman owned business enterprise.
