ADOPTED ON JUNE 22, 1992

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with P & D Technologies, for the engineering design and construction administration of the extension of Runway 10L-28R at Montgomery Field Airport, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-280192, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$300,240.00 from Fund 10520, CIP 31-141.0, Montgomery Field - Runway Extension, is hereby authorized, solely and exclusively to provide funds for this project, and that this amount is to be reimbursed by federal grant funds accepted by Resolution No. R-276609, and that an amount not to exceed \$33,360


