

RESOLUTION NUMBER R-280195

ADOPTED ON JUNE 22, 1992

WHEREAS, the Council of The City of San Diego has read and considered the information contained in City Manager's Report No. CMR-92-198 concerning the widening and enhancement of bridges across State Route 15 in the City Heights area of the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That it hereby approves the bridge enhancements found in Design Alternative C as described further in City Manager's Report No. CMR-92-198, dated June 11, 1992.

2. That the City Manager, or designee, is directed to discuss potential uses for the University Avenue deck and bridge enhancements with the City Heights community, and report back to the City Council with the results of those discussions by August 4, 1992.

3. That it hereby approves the cul-de-sacs on 40th Street, Central Avenue and Terrace Drive as shown in Attachment 1 to City Manager's Report No. CMR-92-198.

4. That the Council hereby requests that the Redevelopment Agency ("Agency) of The City of San Diego commit up to two

million five hundred thousand dollars (\$2,500,000) in Agency funds for additional bridge widenings and improvements to Adams Avenue.

5. That the Council hereby requests that CALTRANS staff seek California Transportation Commission approval to provide the one million dollars (\$1,000,000) in matching funds for the five million dollars (\$5,000,000) International Surface Transportation Efficiency Act ("ISTEA") grant.

6. That the Council hereby commits to the construction of a bicycle path in the SR-15 corridor to Camino del Rio South.

7. That the Council hereby commits to the placement of freeway signs entitled "City Heights Business District" as provided for in California Streets and Highways Code section 100.9.


8. That the Council hereby commits that the Landis Street bridge and other pedestrian bridges affected or built pursuant to this action, will be wheelchair accessible.

9. That the Council hereby requests the State of California to affirm that it will erect signage and direct truck traffic to I-805 as an alternative to SR-15 through Mid-City, during the construction process.

10. That the Council hereby authorizes the establishment of a City of San Diego/CALTRANS/Community I-15 Construction

Oversight Committee to meet bimonthly and monitor concerns associated with the construction of the freeway.
