RESOLUTION NUMBER R- 280199

ADOPTED ON JUN 22 1992

WHEREAS, it is the County of San Diego's legal responsibility, pursuant to Government Code section 26605 and Penal Code section 4000, to house all locally sentenced prisoners; and

WHEREAS, the County's jail system is currently under court order (Hudler and Armstrong) not to exceed holding 3,636 prisoners per day; and

WHEREAS, because of serious overcrowding exceeding 180% of rated capacity in the County jail system, almost all misdemeanants are prevented from being booked; and

WHEREAS, The City of San Diego, in an effort to address the misdemeanor booking issue, opened its own Pretrial Misdemeanant Detention Facility in May 1992; and

WHEREAS, the County opened a medium security jail facility for 512 inmates in October 1991; and

WHEREAS, the County's Chief Administrative Officer has proposed funding to fully operate the East Mesa Maximum Security Detention Facility for 1,500 prisoners in fiscal year 1993; NOW, THEREFORE,
