
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, a 20-year lease agreement with EVERGREEN DISTRIBUTORS, INC., for the use of 70 acres of City-owned land in San Pasqual Valley for the purpose of developing a wholesale tree farm, at an initial annual rent of \$14,000, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No.

RR- 280246 .

BE IT FURTHER RESOLVED, that the lessee's right to install five structures with each to accommodate eight farm workers as described in section 9.7 of the lease, shall be subject to acquiring all required permits and in accordance with all applicable laws and regulations.
