

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$140,000 from C.I.P. No. 68-012.0, "Annual Allocation - City Owned Street Lights in High Crime Areas", is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the use of City forces, up to a maximum of \$70,000, to install the additional street lighting is hereby authorized.
