WHEREAS, on January 13, 1988, the California Coastal Commission certified with suggested modifications The City of San Diego Local Coastal Program (LCP) Implementation Plan; and

WHEREAS, on April 15, 1988, the Council of The City of San Diego accepted the California Coastal Commission's certification of the City's Local Coastal Program Implementation Plan, with modifications; and

WHEREAS, application of the Resource Protection Ordinance within the Coastal Zone requires an amendment to the Local Coastal Program Implementation Plan; and

WHEREAS, the Council, upon hearing all public testimony, has reviewed the proposed amendment to the Local Coastal Program Implementation Plan required by the application of the Resource Protection Ordinance; NOW, THEREFORE,



BE IT FURTHER RESOLVED, that this local coastal program amendment shall become effective 30 days after the certification of the Local Coastal Plan Amendment is unconditionally certified by the California State Coastal Commission.
