WHEREAS, the Pacific Estuarine Research Laboratory (PERL), affiliated with the Biology Department at San Diego State University, was developed in 1984 with funding from the National Oceanic and Atmospheric Administration's Office of Coastal Zone Management, to support both professional and student research in coastal wetlands; and

WHEREAS, the California State Resources Agency, the California State Coastal Conservancy, and San Diego State University have since developed further PERL facilities and built wetland habitats for wildlife use; and

WHEREAS, PERL projects in the past several years have helped to solve local and national estuarine management problems in the areas of coastal wetland restoration, impact of sewage inflows, and wastewater management; and

WHEREAS, studies of PERL scientists include the Tijuana Estuary, Sweetwater Marsh National Wildlife Refuge, San Diego River Estuary, wetlands of Mission Bay and Famosa Slough, Los Penasquitos Lagoon and San Elijo Lagoon; and

WHEREAS, PERL scientists serve as technical advisors at the request of many local, state and national agencies involved in natural resource management; and

WHEREAS, many entities that participate in decision-making processes, including the City and County of San Diego, the Port

of Los Angeles, the US Army Corps of Engineers, CALTRANS, the California State Coastal Conservancy, the California Coastal Commission, USDI Fish and Wildlife Service, the California Department of Parks and Recreation, and Friends of Famosa Slough, have been served by the advise and expertise of PERL scientists; and

WHEREAS, the recent publication of The Ecology of Tijuana Estuary by Joy B. Zedler, Christopher S. Nordby and Barbara E. Kus has called attention to this estuary as worthy of national recognition; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, in honor of the many contributions by the Pacific Estuarine Research Laboratory and Director Joy Zedler, Bruce Nyden, John Boland, Susan Williams, Barbara Kus, and Christopher Nordby, does hereby declare July 6, 1992 as PERL DAY in San Diego.
