RESOLUTION NUMBER R- 280276

ADOPTED ON JUL 06 1992

WHEREAS, the San Diego Police Department desires to expend through the San Diego Data Processing Corporation five hundred and fifty thousand dollars (\$550,000.00) of Federally Seized and Forfeited Assets Fund for the acquisition of equipment and development of various data processing projects; and

WHEREAS, the increased automation resulting from such expenditures will enhance the department's ability to perform its mission; and

WHEREAS, there will be no unbudgeted ongoing costs or impact on the General Fund created by these expenditures; and

WHEREAS, an expenditure of two hundred and fifty thousand dollars (\$250,000.00) would purchase equipment allowing police officers to originate reports from the field on portable computers which would be downloaded for supervisory review and electronically transmitted to the San Diego Police Department Records Division; and

WHEREAS, an additional expenditure of three hundred thousand dollars (\$300,000.00) would purchase unit specific automation for units such as Domestic Violence, Licensing, Criminal Intelligence, Child Abuse and Auto Maintenance to upgrade the Department's efficiency by streamlining workflow; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be and he is hereby authorized to expend through

the San Diego Data Processing Corporation from the Federally Seized and Forfeited Assets Fund a total amount not to exceed five hundred and fifty thousand dollars (\$550,000.00) for the purchase of a pilot automated reporting system and microcomputer equipment with accessories not to exceed three hundred thousand dollars (\$300,000.00) and a pilot automated field reporting system not to exceed two hundred and fifty thousand dollars (\$250,000.00).
