

RESOLUTION NUMBER R- 280287

ADOPTED ON JUL 06 1992

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, a lease agreement with SAN DIEGO NATIONAL SPORTS TRAINING FOUNDATION, a California nonprofit corporation, (the local arm of the United States Olympic Committee), as recommended by staff, for the development of a boathouse and dock facility on Lower Otay Lake, at an initial annual rent of \$11,347, and with an initial \$15,000 lake user fee, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 280287 .


BE IT FURTHER RESOLVED, that the following language shall be incorporated into Section 113 of the lease:

Lessee and City will cooperate to assure that, consistent with the primary purpose of the Olympic Training Center boathouse and course, community rowing and canoe/kayak programs will be developed and implemented at the facilities on Lower Otay Reservoir.

BE IT FURTHER RESOLVED, that the City Manager is authorized to approve any needed changes to the Facilities Management Plan

after receiving input thereon from the Park and Recreation
Committee.
