WHEREAS, The City of San Diego is proud to have avoided the anger, loss of life and destruction of public and private property that exploded in other major cities in the wake of the Rodney King verdict; and

WHEREAS, the Mayor and Councilmembers of The City of San Diego worked closely with the leaders of the minority communities and with the police officers to establish lines of communication, not confrontation; and

WHEREAS, this City's commitment to its citizens is that our city will show zero tolerance for police brutality and likewise for police bashing; and

WHEREAS, it is only with this understanding that we can begin to remedy injustice; and

WHEREAS, this Council urges Time-Warner, Inc. to discontinue the selling or marketing of music that encourages or glorifies the killing of police officers and to exercise their First Amendment freedom of speech to say "NO" to hate messages; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council urgently conveys to Time-Warner, Inc., this

message to discontinue the selling or marketing of music that encourages or glorifies the killing of police officers.
