

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF CURT RESURFACING PROJECT - FY 91 AND 92.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$130,000.00 from General Fund 100 to the allocated reserved fund 10001; and authorizing the expenditure of \$230,000.00 from General Fund allocated reserve 10001, for the purpose of executing this contract and related costs.


