BE IT FURTHER RESOLVED, that the bid of DESIGN FOR HEALTH is hereby accepted as a backup contractor for this service, once that company receives its American Industrial Hygiene Laboratory certification as required by the specifications, per prices on file in the Purchasing Department; terms net 30 days, with an option to renew for one (1) additional one (1) year period with a price escalation not to exceed 5% of bid prices.
