RESOLUTION NUMBER R- 280324

ADOPTED ON JUL 13 1992

WHEREAS, the Police Department of the City of San Diego desires to apply for, and if selected, to accept and expend, a grant award renewal of one hundred eighty thousand, five hundred dollars (\$180,500.00), to be funded in part by funds made available through the California Community Crime Resistance Program, as authorized and administered by the Office of Criminal Justice Planning; and

WHEREAS, the grant award will be used to continue the operation of the Community Crime Resistance Program for a second year; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized, to submit the Grant Application Proposal, a copy of which is on file in the Office of the City Clerk, as Document No. RR- 280324, to the Office of Criminal Justice Planning; and he is further authorized to execute the grant proposal program, including any extensions or amendments thereof.

BE IT FURTHER RESOLVED, that The City of San Diego shall provide all matching funds required for said project, including any amendments thereof, under the program and the funding terms and conditions of the Office of Criminal Justice Planning, and that the cash match will be designated as required.


BE IT FURTHER RESOLVED, that any liability arising out of

the performance of the Grant Award Agreement, including civil court action for damages, shall be the responsibility of the grant recipient and the authorizing agency; the State of California and the Office of Criminal Justice Planning disclaim responsibility for any such liability.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
